

Manure Source and Application Record

Please complete this form if you are applying manure (from on-farm or off-farm sources) to your fields.

Note the following:

1. All soil amendments, including liquid manure, slurries, solid manure, and raw manure shall be applied to land in accordance with nutrient management planning principles.
2. Where manure is applied, the soil shall be sufficiently warm and moist to ensure active bio-oxidation.
3. The timing, rate and method of application shall be designed to ensure that manure application a) does not contribute to the contamination of crops by pathogenic bacteria; b) minimizes the potential for run-off into ponds, rivers, and streams; c) does not significantly contribute to ground and surface water contamination.
4. If using manure from non-organic off-farm sources, you must have the manure supplier complete the form ORG_24A_Manure Annex. The supplier of the off-farm manure must appear on your supplier list.
